Regulations

1. The total credits required for graduation are 30 credits (comprising 12 required credits, 12 elective credits, and 6 thesis credits).
2. Credits per semester: First-year students may register for 6–16 credits in their first semester; all other semesters allow 3–16 credits.
3. Other Courses: Courses that have been reviewed and approved by the Department's Curriculum Committee.
4. To apply for a Master's thesis defense, students must provide proof of academic ethics training. This can be fulfilled by passing the Taiwan Academic Research Ethics Education course or by attending 6 hours of relevant workshops. Final approval for the defense is subject to the review of these documents.
5. Students are permitted to enroll in graduate courses in other departments if required for their research. Up to 9 credits may be recognized toward graduation upon departmental review. Enrollment in courses at other universities is also permitted for subjects not offered by this department, limited to 3 credits for a single course. These external credits will count toward the total elective credit limit for outside departments.
